General Terms and Conditions to be followed for quoting for Annual Mainten ce Contract of 07 Aqua guard Green Pure Chill 80SS RO cum UV water purific machines and 02 Aqua guard Reviva RO water purifier Machines installed in his office

- 1. This AMC Charges should also cover manpower costs, for example; engineers' travel cost and the other incic al labour charges, in rectifying defects developed in equipment. This shall also include the transport charges, if ar equired for shifting of the machines to and from the workshop. It also includes the cost of replacement of any oth art which may require to be replaced due to any other part(s) being defective and no replacement of such part is  $\epsilon$  able.
- 2. The VENDOR shall undertake Preventive Maintenance of the goods under this Annual Maintenance Contract egular intervals of time and keep a record of the same. **The periodicity of such Preventive Maintenance sha e quarterly.** Further, necessary arrangement to depute your service engineer at least once in each week under mation to the Record-I section for providing preventive and remedial service maintenance support is to be madeing the entire contractual period.
- 3. It shall be the responsibility of the VENDOR to furnish along with its Maintenance Bills a Compliance Certificarom all the users as per inventory regarding the Preventive Maintenance, duly authenticated by the user of the Dement, to the VENDOR.
- 4. The AMC charges shall include of consumables and spare items including Compressor ,Heat-Exchange and ther spares but excluding machine body, main chassis, drain tube.

However, the vendor is also directed to explicitly mention in the bid, if any spare parts of water purif machine is to be excluded from the ambit of AMC.

5. Replacement of pre-filter candle ,activated carbon sediment, membrane should be made just at the work order is issued under the supervision of Record-I officials.

- 6. Replacement of worn-out/exhausted parts, including ultra violet lamp with new/rectified spares should be m immediately done during the periodical servicing or breakdown visits during the service contract period under intir on to Record-1 Section.
- 7. The outside of the body of the entire machines including stands should be cleaned with suitable chemical an oth at least once in every week.
- 8. Only spare parts of equal/higher specification/capacity should be used for replacing the defective compone whether permanently or as a stop gap measure while the defective component is being repaired. The newly install omponents should be compatible to the rest of the system. If required, replacement of any other part which may r ire to be replaced due to any other parts(s) being defective and such part is no longer available due its being obso, then such part will also have to be replaced along with the defective part to make the machine operational.
- 9. The maintenance services shall not cover any damage caused to the equipment as a result of accidents or  $\mathfrak c$  s mishandling by the users. Rectification/Repair of such equipment shall be at rates and subject to Change Order  $\mathfrak c$  ess to be agreed upon by the parties. - 11. This office shall also have the right to withdraw any equipment from the purview of such mainter ce as and when desired without assigning any reasons thereof, by providing a 30 days notice in writi to the VENDOR. Maintenance Charges for such equipment shall be payable on pro-rata basis for the pod of service.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
