Office of the Principal Accountant General (Audit-I), Madhya Pradesh, Audit Bhavan, Jhansi Road, Gwalior-474002 invites online bids from reputed, experienced and financially sound company/firm/agency for "**Procurement of 12V/7Ah, 12V/26Ah, 12V/42Ah,12V/120Ah SMF Dry Batteries for UPS**" The bidding documents may be downloaded from GeM Portal as well as from our office website. Time Schedules related to the bids are as below: -

2. The interested companies/firms/agencies are required to submit their offer through GeM portal only. No other mode of submission will be acceptable.
3. Amount of Earnest Money to be deposited is **55,000/-** in the shape of FDR/BG/eBG as per Bid document of GeM, in favor of the **Principal Accountant General (Audit-I), Madhya Pradesh, Gwalior** payable at Gwalior. The validity of the Bank Guarantee/Fixed Deposit Receipt must be **beyond three months starting from the date of submission of the bids.**
4. The Bidder should scan a colour copy of the Earnest Money Deposit and upload it online through GeM Portal.
5. The bids without Earnest Money shall be summarily rejected.
6. Bidders, who are eligible to be exempted from depositing EMD as per existing rule should submit documentary proof thereof along with bid online through GeM Portal.
7. The firm to whom the contract will awarded needs to deposit Performance Security (ePBG) in the form of FDR/BG/eBG which will be 5% of the net contract value. The performance security period will be as per rule of GeM (Warranty period + 2 months).
8. No interest shall be payable on the Earnest Money Deposit returned to unsuccessful bidders.
9. Any future clarification(s) shall be communicated through '**Contact us**' section on our website <https://cag.gov.in/ag1/madhya-pradesh/en>. In case, any corrigendum is issued in respect of this bid, kindly check '**Contact us>Working with us>Tender Notices**' section of our website.
10. The interested companies/firms/agencies are required to furnish the full address of their Office/Telephone No./e-mail id/website address etc. on official letterhead.
11. The on-site warranty period should be at least two years for 12V/7Ah, 12V/26Ah, 12V/42Ah, 12V/120Ah SMF Dry Batteries. Provide the related documents for the same.


12. The batteries are required to be supplied (under buyback option) within one week of receipt of the supply order.
13. **Full payment would be made only after successful delivery and installation of batteries.**
14. This office has the full right to cancel the bid / reduce / increase the number of batteries without assigning any reason(s) to the firm.
15. This office would receive these batteries in the office premises during normal office hours
16. **Conditional bid shall not be accepted.**
17. **The rates tendered by the firm shall be inclusive of buyback of old batteries, transportation, freight charges, installation charges and applicable taxes etc. No increase on any account would be accepted by this office.**
18. The firm (L1) will also provide Connection Cables and other items required for installation of supplied UPS batteries.
19. **The supplier should be registered with Income tax Department and must have valid GST registration. Provide copy of PAN card and GST registration.**
20. The batteries supplied by the firm (L1) will be subject to correctness of the configurations of them. If any battery(s) is/are rejected due to defective/wrong supply, the report of our committee in this regard, shall be final and no correspondence shall be entertained in such matter. The firm should replace the rejected battery(s) within two days otherwise it shall not be the responsibility of this office; in case the supplier reports any theft/damages.
21. All disputes and differences arising out of / or in connection with this bid/order shall be subject to the jurisdiction of courts at Gwalior, Madhya Pradesh.
22. The old batteries will be handed over to the firm (L1) only when the new desired batteries are successfully delivered to this office along with completion of installation of the same by the L1 firm.
23. **The participant should have valid certificates/documents as prescribed on GeM portal.**
24. The participant should possess experience in the supply of such items in previous three yrs of average of fifty percent value of the value of supplied batteries. Documents also need to be submitted in this regard.
25. **The bidder should provide details of the warranty claim of OEM.**
26. **Bidding is allowed only for branded types of batteries otherwise the bid may be rejected.**
27. The Bidder shall be liable to pay compensation for any loss and damage caused to the property of O/o the Principal Accountant General (Audit-1), Gwalior, M.P and other premises within the office by the bidder or his workers.
28. O/o the Principal Accountant General (Audit-1), Gwalior, M.P shall be at liberty to withhold any of the payments in full or in part subject to recovery of penalties as decided by the competent authority.
29. The bidder will be fully responsible for any accident or mishaps involving workers engaged by the bidder and the bidder will pay claims made on this part. The contractor shall indemnify O/o the Principal Accountant General (Audit-1), Gwalior, M.P from any claims arising out of accidents, disabilities of any nature or death arising out of provisions under law, or any other nature in respect of all workers engaged by the contractor.


- 30 Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bid security shall be forfeited to the Government.
- 31 **The bid document, along with terms and conditions, has been uploaded on GeM Portal. The bidders can visit the office sub-site "<https://cag.gov.in/ag1/madhya-pradesh/en>" and see the bid documents. Since, the type of bid is Two Packet (Technical+Financial) hence Bidders are required to be submit Bids accordingly through GeM Portal electronically using valid GeM ID.**
- 32 **The bidders should upload the scanned copies of all relevant certificates, documents etc. including earnest money deposit / exemption certificate as per the requirements contained in the Bid Document in support of their bids. The bidder should seal and sign on all documents etc. uploaded by him, owning responsibility for their correctness/authenticity.**
- 33 The bids shall be summarily rejected, if the bid is submitted other than through online (GeM Portal) or original Earnest Money Deposit / exemption letter and other documents viz. affidavits are not submitted by the Bidders within stipulated date / time as mentioned in bid document.
- 34 The bids shall be evaluated based on the available documents submitted by the bidder. To assist in the examination, evaluation, and comparison of the bids, and qualification of the bidders, this office may, at its discretion, ask any bidder for a clarification of its bid. Any clarification submitted by a bidder that is not in response to a request by this office shall not be considered. Request for clarification from this office and the response shall be as per procedure in GeM portal
- 35 If a bidder does not provide clarifications of its bid by the date and time set in the request for clarification, its bid may be rejected.
- 36 Subject to satisfaction of all terms and conditions of this tender, the bidder quoting the lowest price quoted shall be awarded the contract. If more than one bidder quotes the lowest rate, as per guidelines in GeM portal the buyer shall have two options for placement of Contract: a) Placement of contract by selection of an agency from amongst the L-1 bidders through a Random Algorithm run by GeM system or (b) Placement of contract on any one of the L-1 bidders based on any criteria as deemed fit by the Buyer with appropriate internal approvals.
38. **All the required Documents/certificates should be dated on or before the date of publishing of bid.**



OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU.
