TERMS AND CONDITIONS

- (i)One Resident Service Engineer should be provided at our Chennai office, who must be well versed in Hardware and must be competent enough to attend to any emergency work. The Engineer should have knowledge of installation of Windows OS, frequently used utility applications and other software that are used in this office. He should possess adequate skill to troubleshoot hardware and software issues. Additional technical personnel shall be sent within 24 hrs to attend to and resolve emergency issues or when pending issues are more or when the Resident Service Engineer is unable to attend to it in time. The resident engineer must strictly adhere to the office timings 09.15 am to 5.45 pm and he may be required to stay back after office hours and even on holidays, if required, as instructed by this office.
- (ii) The Resident Engineer shall maintain the following logs: -
- (a) Log of work done indicating details of all calls attended/pending issues/preventive maintenance records.
- (b) Log of spares supplied by the Service Provider which should be kept in our office premises (Hard Disks, SMPS, Keyboard, Monitor, Mouse, RAM, BIOS Battery, etc.).
- (iii) The resident engineer must be raise call/register complaints to HP/DELL/EPSON/ETC for hardware items under warranty as when required.
- (iv)The resident engineer must be able to attend to server, intranet, LAN related requirements.
- (v) Monitor, Keyboard and Mouse connected to CPU (as listed in the Annexure) irrespective of Stock number are to be covered under the AMC.
- (vi) AMC for the above items should comprehensively include preventive maintenance, day to day troubleshooting and replacement of spares as and when necessary at the cost of AMC provider.
- (vii) Some of the items, like printers, desktops which are not covered under AMC shall be quoted for on Call Basis only.
- (viii) Payment for AMC shall be made on completion of each Quarter through ECS and the amount would be released on receipt of invoices with the advanced stamped receipt which may be produced in the first week of the month subsequent to the Quarter ended.
- (ix) The service provider shall execute a Bank Guarantee equal to the 25% value of the contract for the entire period. The bank guarantee shall be valid for a period of 12 months beginning from the first day of commencement of the contract. The undersigned may, at his discretion, waive this guarantee.
- (x) Maintenance shall include installation of all kinds of software including Operating System, Application Software and Anti-Virus Software and its periodic updation etc., which will be provided by this office.
- (xi) AMC contract includes Networking services and Server support: Maintenance of Local Area Network, CISCO, IO Ports, 10 NETWORK SWITCHES, one broadband connection (ACT), network related cabling and maintenance and fixing server/network related issues. The server support includes fixing issues related to the operating system, applications running in the server i.e. exchange server, SQL server, etc. and troubleshooting problems like outdated drivers causing system crashes.
- (xii) There 150 UPS (600 VA) connected to desktops and switches in this office. Though UPS is not covered under AMC, basic troubleshooting/service and changing batteries has to be done by the service engineer.
- (xiii) All spares for printers are covered under the contract except Teflon rollers, Fuser Assembly and image drum kit.

- (xiv) No component(s)/spare(s)/hardware shall be **removed** / **replaced** without informing the competent authority in **writing**.
- (xv) The AMC agreement shall be in force till 31.03.2025 from the date of entering into agreement or from 01.04.2024 or the date specified whichever is later and is liable to be terminated at any time giving a notice of one month.
- (xvi) The AMC service provider shall be able to rectify the problems within the maximum period of 24 hours. In the event of the problem not being solved in time, alternate arrangements (Stand-by) shall be made by the service provider to ensure continuity in work.
- (xvii) In case no alternate arrangement is made within 48 hours, the delay time will be worked out and the proportionate amount deducted from the bill.
- (xviii) You are requested to furnish past experience in this field, staff strength and escalation matrix
- (xix) Preventive Maintenance must be taken up by the tenderer in respect of all hardware once in a quarter prior to payment.
- (xx) During the period of contract, any item may be included or withdrawn with proper notice of 15 days.
- (xxi) Acceptance of all terms and conditions should be specifically mentioned in the quotation itself and any quotation without specific acceptance of terms and conditions will be rejected.
- (xxii) Before submitting the quotation, you may visit the premises of this office during office working hours to physically inspect the items and ensure that functional status of all the equipment. This office would not be responsible for omissions and commissions, if the service provider does not make a physical verification of items listed in the annexure. Otherwise, it shall be deemed that the service provider has unequivocally accepted the items mentioned.
- (xxiii) Actual items may increase or decrease by 5 %. Pro rata AMC amount will be paid on this variation.
- (xxiv) Subject to satisfactory completion of the Annual Maintenance Contract for the year ending 31.03.2025, the successful bidder shall upon written confirmation from this Office, extend the AMC for a further period of one year, ending 31.03.2026, at the same unit rates quoted for this tender, with the number of IT assets either increasing or decreasing, which will be intimated during communication of the extension of AMC for 2025-26
- (xxv) A separate agreement will have to be entered into by the successful service provider on awarding the contract.
