- ii) The sealed quotations must be valid for a minimum period of ninety days from the bid submission start date.
- iii) The bidder must be a reputed printer or his authorized representative of the type of product. In case of representative, the authority letter specific from the printer/supplier may be submitted.
- iv) The bidder should have at least Two years experience in Government department, PSUs /reputed Organization and copy of certification working must be furnished along with quotation failing which quotations shall be rejected.
