**NOTICE INVITING TENDER (NIT) FOR
API INTEGRATION OF PENSION SYSTEMS**

The Office of the Principal Accountant General (A&E), Manipur, invites **Sealed Tenders** (Technical and Financial Bids) from eligible, reputed, and experienced **Software Development Firms/Vendors** based in Manipur for undertaking the complete API-based integration and synchronization of the State's pension processing ecosystem.

1. Scope of Work (SOW)

The vendor shall be responsible for developing, testing, and deploying **secure, scalable, and API-based integration** modules between the existing NIC-developed State Government systems and the AG Office's SAI (Pension) Software.

Phase	Integration Point	Required Functionality
Phase I: Case Submission	State Pension Processing System (NIC, Manipur) and SAI (Pension) Software (AG Office)	Establish secure API links to enable the online, seamless submission of new pension cases, family pension cases, and corresponding electronic service books (e-Service Books) from the State Government to the AG Office for verification and authorization.
Phase II: Payment Authorization	SAI (Pension) Software (AG Office) and State Pension Payment Software (NIC, Manipur)	Establish secure API links for the online generation and transmission of digitally signed final authorization documents , including Pension Payment Orders (PPOs), Gratuity Payment Orders (GPOs), and Commutation Payment Orders (CPOs). This must ensure the automatic and accurate transfer of authorized pension data for online disbursement.

2. Eligibility and Qualification Criteria

- Firms/Vendors must be **legally registered and physically based within the State of Manipur**.
- Must possess relevant experience in **government software integration projects**, with demonstrable expertise in secure API-based data exchange and

synchronization.

- The vendor must commit to providing comprehensive **support, security compliance documentation, and technical documentation** (including API documentation) post-deployment for a minimum period of one year.
- Must provide valid registration documents (PAN, GSTIN, Company Registration/Udyam Registration, etc.).

3. Tender Submission Requirements

Bidders must submit their proposals in **two separate sealed envelopes** (Technical Bid and Financial Bid) enclosed within a third main envelope.

Envelope 1: Technical Bid	* Detailed technical proposal outlining the proposed approach, secure API architecture, methodology, implementation timeline (Gantt Chart), and complete deliverables. * Company profile and documentary proof of relevant work experience (completion certificates/work orders). * Compliance statement for support, security, and documentation requirements.
Envelope 2: Financial Bid	Estimated price quotation (in INR), clearly itemized for each phase of the SOW, inclusive of all statutory taxes (GST, etc.) and post-implementation support costs for the commitment period. (Should NOT contain any technical details.)
