### Auction Terms and Conditions:

1. Only the firms registered with State Pollution Control Board (SPCB) and Central Pollution Control Board (CPCB) can participate in the auction. The Possession of valid Pollution Control Board Certificate as recycler/pre-processor agency is mandatory. The certificate will be checked by o/o AG (A&E) Punjab for allowing the vendor to participate in the auction.
2. An "Earnest Money Deposit (EMD)" to the tune of Rs. 5,000/- (Rupees Five thousand only) in the form of crossed Demand Draft drawn in favor of " **PAO, O/o AG (A&E) Punjab**" shall be submitted in this office (ITGD section) on or before the date of auction. The firm who fails to submit the Demand draft will not be allowed to participate in the auction.
3. Maximum of 1 representative per participating firm will be allowed inside the office premises on the auction day. The representative must carry valid Government ID Proof and duly filled application as per annexure A (Attached).
4. The goods shall be auctioned to the H1 i.e. highest bidder (Price shall be all inclusive i.e. Taxes, Carriage, Laboure etc) and the material shall be lifted on 'as is where is' basis. However, Office of the Accountant General (A&E), Punjab & UT, Chandigarh reserves its right not to accept the bid or cancel the sale without assigning any reason.
5. For a prospective bidder, who want to inspect the E-waste material, can visit office between 10:00 AM to 4:00 PM excluding Saturday, Sunday and Public Holiday from 20.11.2025 to 26.11.2025.
6. Guidelines issued by the Ministry of Environment, Forest & Climate Change will be applicable in this regard. These hardware/devices are to be dismantled/recycled as per guidelines of State Pollution Control Board (SPCB) and Central Pollution Control Board (CPCB) guidelines through registered E-waste agencies. Decision of the office regarding sale of the goods is final, binding and unquestionable.
7. The successful bidder / Purchaser will have to deposit 25% of the bid amount immediately, i.e. on the day of auction itself, in cash or through Demand Draft in favor of Pay and Accounts Officer/IAAD, O/o the Accountant General (A&E), Punjab & UT, Chandigarh. The balance amount shall be paid within 7 days further; the bidder has to lift the auctioned items within 5 days from receipt of final payment.
8. If the balance amount is not paid within 7 days or if the successful bidder fails to adhere to terms of sale, time or commits default in any manner than this office reserve the right to forfeit the EMD amount and also to re-auction the listed goods again without any notice.
