## **GENERAL TERMS AND CONDITIONS**

## 1. Disposal Basis

The disposal shall be carried out strictly on an "as-is-where-is" and "no complaint" basis. No warranty, guarantee, or assurance of any kind is provided regarding the condition, completeness, or fitness for use of the items.

## 2. Eligibility Criteria

Only bidders registered with the Central Pollution Control Board (CPCB) or the State Pollution Control Board (SPCB) as authorized e-waste recyclers/dealers shall be eligible to participate. Valid registration certificates must be enclosed with the bid.

#### 3. Bid Submission

Bids shall be submitted in sealed covers superscribed with "Tender for Disposal of Obsolete IT Equipment" along with the bidder's name and contact details. Each bid must include:

- a. Copy of Government-issued ID (for individuals) / Company registration certificate (for firms)
- b. Valid CPCB/SPCB registration
- c. GST registration and PAN card
- d. Signed copy of the tender notice as token of acceptance of all terms Incomplete or unsigned bids are liable to be rejected.

#### 4. Evaluation and Award

The highest valid bid above the reserve price will be accepted, subject to verification of eligibility documents.

In case of a tie, preference will be given to bidders with higher recycling authorization validity and experience.

The decision of the competent authority shall be final and binding.

## 5. Payment Terms

The successful bidder shall deposit 100% of the bid amount within 3 working days from the date of award notification through a Demand Draft or NEFT in favor of "PAO, O/o PAG(A&E), Telangana, Hyderabad" or Account details provided at the time of bid submission. Failure to make payment within the stipulated period shall result in forfeiture of award and retendering at the bidder's risk.

#### 6. Lifting and Transportation

The successful bidder shall make arrangements for lifting, loading, and transportation of the e-waste at their own cost and risk.

All items must be cleared from the premises within 10 days from the date of award. Delay beyond the stipulated period shall attract a penalty of ₹500 per day. Any damage to Government property during lifting or transit shall be recovered from the bidder.

#### 7. Environmental Compliance

The successful bidder must ensure safe, lawful disposal and recycling of all materials in accordance with the E-Waste (Management) Rules, 2022.

A certificate of disposal/recycling from the authorized recycling facility must be submitted to this office within 30 days of lifting the materials.

## 8. Validity of Quoted Rate

The proportionate rate quoted in this tender shall remain valid for any similar disposal requirements of e-waste arising within the next 12 months from the date of award.

## 9. Right to Reject or Cancel

The Office reserves the right to cancel, postpone, or modify the tender process, fully or partly, without assigning any reason. No claim or compensation shall be entertained on this account.

## 10. Dispute Resolution

Any dispute arising out of this tender shall be subject to the jurisdiction of Hyderabad courts only.

#### 11. Bid Security

Earnest Money Deposit (EMD): Earnest Money Deposit of Rs.1,800/- (Rupees one Thousand eight hundred only) in the form of Bank Guarantee/Demand Draft of any nationalized bank must be deposited by bidders along with their duly filled up bidding documents.

#### 12. Integrity Clause

All bidders must comply with the Integrity Pact principles of the Government of India to ensure fairness and transparency.

### 13. Sub-letting of Work

The contractor shall not sublet, transfer or assign the contract or any other part thereof without prior written permission of the competent authority of the office of the Principal Accountant General (A&E) Telangana, Hyderabad. In the event of the contractor contravening this condition, the competent authority shall be entitled to place the contract elsewhere on the contractor's risk and cost and the contractor shall be liable for any loss or damage, which the office of the Principal Accountant General (A&E) Telangana, Hyderabad may sustain in consequence or arising out of such replacing of the contract.

#### 14. Contractual Obligations on the part of Contractor

- i. The Contractor shall be present whenever called upon by this office to do so in order to lift the e-waste items as per the tender document.
- ii. No sorting or segregation of e-waste items shall be allowed inside the office premises.
- iii. No assistance shall be provided by the office to the Contractor in executing the obligations as per the Contract, and no expenses or claim of the Contractor in this regard shall be entertained whatsoever.
- iv. No price variation shall be entertained during the currency of the contract. v. The Contractor shall be required to deposit the cash amount on account of taking e-waste items as per the terms and conditions of the contract before lifting the materials from the office premises.
