- 1. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

महानिदेशक लेखापरीक्षा (इंफ्रास्ट्रक्चर), दिल्ली के कार्यालय में लगभग 1332 वर्ग मीटर (लगभग 14340 वर्ग फुट के क्षेत्र में) में मच्छरों, कृंतकों, तिलचट्टों, कीड़ों और दीमक नियंत्रण के लिए वार्ष िक आधार पर व्यापक कीट नियंत्रण उपचार करने के लिए पंजीकृत और अधिकृत फर्मों से बोलिय ां आमंत्रित की जाती हैं। कोटेशन प्रस्तुत करने के लिए निम्नलिखित नियम और शर्तें हैं।

Terms and conditions of Comprehensive Pest Control Treatment

Bids are invited from registered and authorized firms to carry out Compr ehensive Pest Control treatment for Mosquitoes, Rodents, Cockroache s, Insects & Termite Controls in the Office of the Director General of Audit (I nfrastructure), Delhi in an area consisting of approximately 1332 Sq meters (approx. 14340 sq. feet) on an annual basis. The following are the terms and conditions for furnishing quotations.

- The comprehensive Annual Maintenance Contract shall be valid for a pe a) riod of twelve months (one year) initially which can be extended at mutua I consent basis at the same rates and existing terms and conditions.
- The rate quoted shall remain in force for the full period of contract. No d b) emand for revision of rates on any account whatsoever shall be entertain ed during the currency of the contract.
- The AMC provider should have an office in Delhi. c)
- d) The AMC shall be Comprehensive. The maintenance contract shall cover services once fortnightly for Vector control (Mosquitoes/insects) and o nce in a month for Rodents, Cockroaches, & Termite Controls eithe r Saturday or Sunday and on need basis on any other day for which no pa yment shall be paid separately.
- The company shall provide necessary pest control services within reaso e) nable time in case of intermediate complaints within 24 hours from the ti me of registration of complaint.
- f) The contractor shall attend to all the emergency services on all working days. The services are to be attended before and after the usual office ti me and even on holidays.
- If the vendor fails to attend the complaint within 24 hours from the time g) of lodging complaint, a penalty of Rs.200/- per day will be levied till the da

te on which the complaint is resolved. Such amount of penalty will be ded ucted from the quarterly payment due to the vendor for that quarter.

- Payment will be made on Quarterly basis after the completion of the AM C for that quarter and after submission of invoice by the vendor. Payment will be made only after satisfactory work done by the Service Provider as c ertified by the competent authority.
- i) The approved Preventive Maintenance Schedule is to be strictly followed
- j) Proper pest control treatment is a must and shall cover whole area for w hich this AMC is contemplated.
- **k)** No other charges like Transportation, Fare, etc., for providing the servic es, will be payable.
- Office of the DGA (Infrastructure), Delhi reserves the right to terminate the contract at any time without assigning any reasons. Any decision of the DGA (Infra.) with regard to the AMC will be binding on the contractor.
- m) Office of the DGA (Infrastructure), Delhi shall not have any liability, financ ial or otherwise, for any harm/damage/injury caused to manpower deploye d by the Contractor in the course of performing AMC. Neither the contract or nor his worker shall have any claim on Office of the DGA (Infrastructure), Delhi for compensation or financial assistance on this account.
- n) The firm/contractor shall be solely responsible for any injury / accident ca used to the person/personnel deployed by the contractor / firm during the performance of the job/AMC.
- The agency shall use the best quality treatment material and chemicals f or the treatment.
- **p)** The contractor shall arrange for prompt disposal of the remains to ensur e cleanliness of the premises.
- This maintenance contract is subject to the laws of the land, and dispute s arising if any, are settled within the jurisdiction of NCT of Delhi.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without

- specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
