## TERMS AND CONDITIONS FOR OPEN PUBLIC AUCTION

### OF UNSERVICEBLE/OBSOLETE COMPUTER HARDWARE ITEMS

1. The prospective bidders/firms can inspect the computer articles/items O/o Pr. Accountant General (Audit) Himachal Pradesh, Shimla – 171003 on any working day between 10.30 to 16.30 hrs. except Saturday & Sunday up to 18.03.2025 from the date of publication of the notice.
2. Principal Accountant General (Audit) Himachal Pradesh, Shimla or his nominee will reserve the right to place the items either in lot or lots of unit or as a unit.
3. Items are strictly to be sold on "As is where is" basis.
4. Bidders will have to produce the proof relating to registration as per e-waste rules with Central Pollution Control Board or H.P. Pollution control Board.
5. The attorneys, brokers and other persons authorized to act as agent to bid on behalf of their clients or principals, shall be bound to disclose the full name and status of their clients or principals and shall furnish such information and documents as may be required under orders of the Competent Authority.
6. All offers will be subject to the approval of the Competent Authority or his nominee and the offer will remain open until they are accepted or rejected.
7. The successful bidder will be required to pay 100% amount of the bid value in cash/cheque/DD on the spot at the fall of hammer. Upon receipt of full payment, gate pass to lift the material from office premises will be issued by GAD Section.
8. All items will lie on the spot entirely at the risk of purchaser from the time they are knocked down and must be removed /cleared within two (2) days after receipt of full payment. Successful bidders will arrange necessary equipment/labour at their own cost for lifting of the items/materials from office premises.
9. Municipal due, Excise, GST etc. if any, will be required to be paid by the purchaser on the material liable to such charge.
10. Pr. Accountant General (Audit) Himachal Pradesh, Shimla reserves the right to reject the highest or any other bid without assigning any reason/ground thereof.
11. Pr. Accountant General (Audit) Himachal Pradesh, Shimla reserves the right to cancel/withdraw any items from the auction without assigning any reason whatsoever.
