## **Scope of Work:**

## 1. Preparation and Verification of GST Data:

The firm will be responsible for the accurate preparation and verification of GST-TDS data for iCISA on a monthly basis.

#### 2. Coordination with iCISA:

The firm shall liaise with iCISA to gather all necessary information and documents required for the preparation of GST data.

## 3. e-Filing of GST-TDS:

The firm will handle the electronic filing of GST-TDS returns in **form GSTR-7** through the GST portal for the respective months.

#### 4. Challan Generation:

Upon successful filing, the will generate and provide the challan for the uploaded GST-TDS returns.

## 5. TDS Certificate Generation:

The firm will obtain the GST-TDS certificates in **Form GSTR-7A** from the GST portal and provide them to iCISA.

- 4. In case of failure to file the returns by the awarded firm, the Department shall reserve the right to get the work done by another firm, for which the cost of work has to be borne by the awardee firm.
- 5. The successful bidder has to submit the TDS files prepared in a CD/Pen Drive to the Department.
- 6. iCISA reserves the right to terminate the contract at any time, if the services of the firms are not found satisfactory.
