GENERAL TERMS AND CONDITIONS:

- 1. Eligibility/Qualification Criteria: The bidder shall have to be registered as recyclers/dismantlers/pre-processors of e-waste with MOEF/Central Pollution Control Board, Government of India or with the State Pollution Control Board or State Government dealing with e-waste. Bids received from the firms other than so registered will be summarily rejected. Document on registration and validity of the authorization shall be produced with the bid. Agencies without having above registration and authorization will not be allowed to participate in the bid. The office of the Accountant General shall select the 'eligible highest bidder' for selling of old unserviceable and obsolete computer hardware in the prescribed Proforma (*Annexure-II*).
- 2. <u>Location of the goods</u>: The above old computer hardware for sale are kept in the room No.59 of TAD building of the office of the Accountant General (A&E)-I, U.P., Prayagraj.
- **3.** <u>Present condition</u>: The bidders can inspect the condition of goods before submitting their tender by visiting this office on any working day during 12.30 PM to 4.00 PM before 08.11.2025.
