7.	If any Bidder does not qualify in technical evaluation, the financial Proposal of the Bidder shall not be opened.				
8.	The price should not be mentioned in the Technical bid in any form or manner. In case the prices are mentioned in the technical bid, the offer will be liable for rejection.

10.	The financial bid will be opened in respect of only those Bidders whose documents are found in order and whose items qualify technically. - 4. The product profile of the Bidder along with last 3 years' turnover, not less than 50 lakh per year. Audited Balance Sheet and Profit and Loss account or CA Certificate for last three years should be submitted.
- 5. The Bidder shall be Original Equipment Manufacturer (OEM) or the Authorized System Integrator/ Partners / Dealer of OEM. In case the Bidder is offering from more than one OEM, he shall be authorized System Integrator/Channel Partner/Dealer for all OEM's. Makes/Brands offered by him. Proof of the above shall be submitted in the form of "Bid/Tender Specific authorization" of dealership/SI/Partnership issued by the respective OEM.
