The Terms & Conditions are given below: -

1. Bidders must have a registered office/branch in tri-city (Chandigarh, Mohali & Panchkula) since 01.01.2025. Documentary proof of the same must be provided.
2. The Bid Security (EMD) amounting to Rs. 15,000/- in the form of Demand Draft has to be submitted in favour of "The Principal Accountant General (A&E) Haryana", which will be returned to unsuccessful bidders within 30 days of disqualification from bid. Bid Security of successful bidder will be kept with this office throughout the contract period as a performance bank guarantee. Note: Demand Draft must be valid till 31.05.2026.
3. Successful bidder will lift the paper waste and other scrap material as and when informed or on bi-monthly basis during the contract period. The material will be lifted only after submission of Demand Draft of payment due to this office.

4. Undersigned reserves the right to reject or accept any tender/quotation without assigning any reason.
5. The solid waste paper will have to be lifted from the premises of the office within three days on receipt of intimation from this office otherwise the above material will be sold at the risk and cost of contractor.
6. Tender will be opened on 18.03.2025 at 11:30 AM.
7. The contract will firstly be awarded for one year. Further extension/renewal of work contract is subject to satisfactorily and successfully completion of work and at discretion of Competent Authority.
8. In case tender/contractor leaves the work incomplete for any reason during the period of the contract or does not work as per tender' specification, performance security amount will be forfeited.
9. The above said terms and condition must be accompanied with the quotation signed by the tenderers in token of their acceptance.
10. In case any dispute arises both the parties will be bounded to accept the decision of Principal Accountant General.
11. The contract shall be subject to the jurisdiction in the court of Chandigarh only.
