TERMS AND CONDITIONS FOR DISPOSAL/AUCTION OF VEHICLE

The office of the Principal Accountant General (Audit) intends to dispose off one **Mahindra Scorpio** bearing Registration No. **NL-10-8578 (2012 Model)** which is lying in the premise of the Office Complex.

1. The firm/tenderer interested in purchasing the vehicle may send their quotation in the proforma given below along-with earnest money of ₹ **10,000/-** only in favour of **Sr. Audit Officer (Admn) [Cash or DD]** in a sealed envelope superscripted as “Quotation for old and condemned Mahindra Scorpio”.
2. The quotation may be addressed to the Sr. Audit Officer (Administration), Office of the Accountant General (Audit), Nagaland – Kohima and should reach on or before 25.01.2023. The quotation will be opened on **27.01.2023 at 11:00 AM** in the chamber of Sr. DAG (Audit) in the presence of the tenderers or other representatives who wish to be present at that time.
3. The vehicle will be disposed off on “as is where is basis”.
4. The vehicle can be inspected by interested parties after obtaining permission from the Sr. Audit Officer (Administration) on working days (Monday to Friday).
5. The successful tenderer will have to remove the vehicle from the office premises on or before 08.02.2023, if his quotation is accepted at his own expenses and after making all necessary payments.
6. The tenderer will have to attach an attested copy of valid **ID Card/Aadhar Card/Voter ID card/ PAN card** and two recent passport size photographs duly attested.
7. The successful tenderer will be responsible for getting the registration certificate of the vehicle in his name expeditiously. This office will not be responsible for any lapse on the successful tenderer’s part.
8. The tenderer will not be allowed to withdraw their quotations failing which their earnest money will be forfeited.
9. Quotations received after due date/time and without earnest money will not be entertained.
10. The successful tenderer who take possession of the vehicle would be responsible for the bonafide use of the vehicle.
