**The Terms & Conditions are given below: -**

1. The work contract will be awarded for Financial Year 2026-27 & 2027-28. Extension for 2<sup>nd</sup> year will be subjected to satisfactory completion of work for the 1<sup>st</sup> year and at discretion of competent authority. After 02 years further extension/renewal of work contract for 01 more years will be subject to satisfactorily and successfully completion of work and at discretion of Competent Authority.

2. Bidders must have a registered office/branch in tri-city (Chandigarh, Mohali & Panchkula) since 01.01.2026. Documentary proof of the same must be provided.
3. The Bid Security (EMD) amounting to Rs. 15,000/- (Rs. Fifteen Thousand only) in the form of Demand Draft has to be submitted in favour of “The Principal Accountant General (A&E) Haryana, Chandigarh”, which will be returned to unsuccessful bidders within 30 days of disqualification from bid.
4. Successful bidder has to submit performance bank guarantee amounting to Rs. 30,000/- in this office in the form of Fixed Deposit Receipt (FDR) and in favour of “The Principal Accountant General (A&E) Haryana, Chandigarh”, within 15 days from receipt of award letter. Bid Security (EMD) deposited at the time of tender submission will be returned after receipt of performance bank guarantee. Note: FDR must be valid till 31.05.2028.
5. Successful bidder will lift the paper waste and other scrap material as and when informed or on bi-monthly basis during the contract period. The material will be lifted only after submission of Demand Draft of payment due to this office.
6. Undersigned reserves the right to reject or accept any tender/quotation without assigning any reason.
7. The solid waste paper will have to be lifted from the premises of the office within three days on receipt of intimation from this office otherwise the above material will be sold at the risk and cost of contractor.
8. In case tender/contractor leaves the work incomplete for any reason during the period of the contract or does not work as per tender’ specification, performance security amount will be forfeited.
9. The above said terms and condition must be accompanied with the quotation signed by the tenderers in token of their acceptance.
10. In case any dispute arises both the parties will be bounded to accept the decision of Principal Accountant General.
11. The contract shall be subject to the jurisdiction in the court of Chandigarh only.
