- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. - 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

Additional Terms and Conditions

- 1. The bidder should read the **detailed bid documents** attached with this bid ve ry carefully before bidding.
- 2. Filling the **Price-break up** as per the format attached with this bid is mandato ry. In case of non-compliance the bidder will be outrightly disqualified at the fin ancial stage.
- 3. Filling **all relevant forms** attached with this bid is mandatory. In case of non-compliance the bidder will be outrightly disqualified.
- 4. For better understanding of the scope of work a pre-bid meeting has been arra nged on **28.05.2024 at 11:00 AM** in the Conference Hall, O/o Director General of Audit (Infrastructure), Delhi, 3rd Floor, A wing, Indraprastha Bhawan, Delhi 11 0002. Attending pre- bid is mandatory. In case of non-compliance the bidder will be outrightly disqualified.
- 5. Disbursement of Salary: The Contractor shall disburse salary to its deployed m anpower inclusive of DA, if any, rates as per the order of Chief Labour Commissi oner, Ministry of Labour and Employment, Govt. of India, revised up wards ever y after six months latest by 5th of every month, failing which penalty of Rs.100/-per day per person in 1st instance and Rs 200/- per day per person for 2nd inst ances will be imposed up to 15th of the month and the contract shall be liable to be terminated. In case the Contractor fails to make the payments by the stipulated date and time, the Contract is liable to be terminated and the Contractor is liable to be blacklisted and Security Deposit / Performance Bank Guarant ee submitted by the Contractor shall be forfeited and Bank guarantee will be en

cashed.

- 6. The contract for providing Housekeeping Services shall be deemed to have come into force on 01.07.2024.
- 7. The list of the material are prepared based on the past and current consumption pattern. However, Aforesaid quantities are not exhaustive and may vary depending on the monthly requirement. For proper maintenance, suitable cleaning material which is environment friendly, no harmful to humans and property should be used.
- 8. The material shall be issued to the Staff of the Agency on Monthly basis or as per the requirement. The consumables supplied shall be of good quality and standard i.e. ISI Marked and of well recognized brands preferably of brands as mentioned above and for which the bidder has quoted in Financial Bid. Any deviation in the material quality and quantity quoted i.e. supply of unbranded and Duplicate items will invoke penalty as decided by the competent authority.
- 9. Rate of the cleaning materials shall be quoted inclusive of GST and No service charge will be applicable on the supply of cleaning materials. No any request for change in rate for the materials will be considered by the office.
- 10. If any abnormal higher or lower price has been quoted by the contractor, an ex planation will be sought by the bidder and if no satisfactory reply is received with the stipulated date as per GeM. The bid will be out rightly cancelled.
- 11. Delay in supply of Consumables as required by the office will attract a penalty of Rs. 2,000/- per day delay.
- 12. The verification of the material (quantity and quality) will be done every time by the this office.
- 13. For Floor area of **approx. 14336 sq. ft.** the minimum no. of workers required will be 02. In case on any day if the no. of workers is less than the minimum spe cified number the payment will be deducted from the bill of the contractor on a proportionate basis.
- 14. If the Contractor suspends or abandons the house keeping services without giving sufficient notice thereof the Security Deposit with the O/o DGA (Infrastruc ture) shall be forfeited, and he/she shall also be liable for legal action as deeme d fit for such act.
- 15. The Contractor must use standard size **vacuum cleaners** and **Floor mopping Machine** and ensure vacuum cleaning of Blinds & Windows and deep cleaning of the other areas of the office using the Floor Mopping Machine on regular basi s. A penalty of Rs. 5000/- per month will be levied on the Contractor in absence of this equipment.
- 16. In case it is noticed and found at any stage that the statutory regulations relating to EPF, ESI bonus etc. are not being complied with, then the O/o DGA (Infrast ructure) shall have the right to deduct and withhold up to 50% of total dues of the Contractor till the time the proper documents showing proof of compliance a renot submitted.
- 17. The contractor will not ask for any enhancement of approved rates other than i ncrease in minimum wages as per minimum wages act of Ministry of Labour an d Employment, Govt. of India, during the period of contract and it shall be the r esponsibility of Contractor to pay the wages, ESI, EPF, Bonus etc. (as admissible under the relevant Act) to its employees.

18. The contractor shall submit the payment proof the GST paid along with next m onth Bills.

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
