



## Annexure 'B'

### Terms & Conditions

- (i) Unserviceable material will be sold out on “as is where is basis” to the highest bidder.
- (ii) The successful bidder shall deposit the bid amount in cash on the same day i.e. 27-9-2019.
- (iii) The interested bidders have to provide the business detail and deposit Rs. 5000/- as security/EMD in cash on the day of auction. The amount is refundable to the unsuccessful bidders except first highest bidder which will be adjusted in the sale value.
- (iv) The unserviceable material can be inspected on any working day between 10.00 a.m to 4.00 pm on 25th and 26<sup>th</sup> September 2019.
- (v) The possession of unserviceable material will be given to highest bidder on the receipt of full amount of bid value on the spot after completing all the formalities.
- (vi) The highest bidder/purchaser will have to lift the unserviceable material on the same day at their own cost.
- (vii) In case, if the highest bidder does not lift the material on the same day, the bid security/EMD of Rs. 5000/- deposited by him shall be forfeited.
- (viii) If any dispute arises on the day of auction relating to auction, the decision of the Pr. Accountant General shall be final.
- (ix) The Pr. Accountant General reserves the rights to cancel the auction without assigning any reasons.
