



(Not applicable where boarding lodging of audit team is in Circuit Houses, Guest House. Inspection Bungalows, messes etc.) [Authority vide Hqrs. Letter no. 3368 BRS 2012 dated 27th June, 2012! All the field officials have been directed to join the office on declared holiday in State Govt, on Suffix prefix of weekend only.

In case of two or more consecutive holidays (including Sundays), the field party, withing 150 km from Headquarter, shall take evening transit on the day preceding the holiday to report to Headquarter and shall

further, avail morning transit on the day succeeding the holiday to join the respective auditee units

The Party will perform their respective allotted works/theme work with compliance of instruction guidelines/SoP issued by this office as well as Ministry of Home Affairs related to Covid-19.

5. Audit Team have to submit Desk Review within 2 days of commencement of Audit.

For Desk study, Voucher-wise VLC data is to be arranged in ascending/descending order in Excel Sheet and Risk Analysis is to be done on the basis of value of Vouchers item-wise.

Party is directed to provide findings as per the Audit Design Matrix(ADM) circulated and other

instructions to Vetting.

The last audit of audit entities are to be matched with the data provided by the auditee unit. In case of

discrepancies, the same may be intimated to Headquarters immediately.

As per Accountant General (Audit) Bihar order dated 14/04/2023 three IRs of CS-cum-CMO, ACMO and DHS would be drafted and findings of Sadar Hospitals, PHC, CHC etc. according to transfer of funds would be incorporated in the three IRs.
